 - b) *When called upon, the person shall come to the podium, state his/her name and address for the record, and, if speaking for an organization or other group, identify the organization or group represented. Whenever any group of persons wishes to address the Planning Commission on the same subject matter, the Chair may, at his/her discretion, request that the group choose a spokesperson to address the Commission.*
 - c) *All remarks should be addressed to the Planning Commission as a whole, and not to individual Commissioners. Questions, if any, should be directed to the presiding Chair who will determine whether, or in what manner, an answer will be provided.*
 - d) *Every person addressing the Planning Commission will be limited to three (3) minutes or such reasonable time as is granted by the majority of the Planning Commission.*

- 1. Tentative Planning Division projects for the February 10, 2010, Planning Commission meeting (all items listed below are tentatively scheduled).**

a) WIRELESS COMMUNICATION FACILITY (WCF 09-001):

Major Wireless Communication Facility permit to allow a sixty-foot (60') high freestanding mono-pole, on an existing supply material building, consisting of three sectors of antennae, with each sector containing three antennae each, and related ground equipment in the C-4 (Highway Commercial) zone on a property located at 133 W. Foothill Blvd.

b) CONDITIONAL USE PERMIT (CUP 09-014):

Conditional Use Permit to allow the relocation of a community health center (East Valley Community Health Center) to an existing, vacant 24,400 square-foot building on an 89,581 square-foot (2.05 acres) property within the C-4 (highway commercial) zone located at 1555 S. Garey Avenue.
